President's Report

WILL GOODIER

It was a year of initiatives, consolidation, successes and some failures- all covered in the Annual Report- but overall Table Tennis Australia moved forward positively in terms of growth and achievements. It is pleasing that during a year of such growth the accounts reflect a surplus thanks to the support of our sponsors and the attention to detail by the Finance Director and the Staff.

Our initiatives include the National Insurance Scheme and the development and implementation of the new constitution as well as the substantial growth of our PPP programme with the generous support of the Australian Paralympic Committee.

In terms of consolidation, it is pleasing to see how board teamwork developed during the year. Networking continued at an accelerated pace both internationally and in Australia, mainly by the CEO and President with the Australian Sports Commission, Australian Commonwealth Games Association, Australian Olympic Committee, Australian Paralympic Committee and International Table Tennis Federation.

Successes in 2010 included the National Tour aimed at a better communication between Table Tennis Australia and the member states, the adoption of our new identity and constitution as a Company Limited by Guarantee and acceleration of our Paralympic Preparation Program. Behind the scenes, where we do most of our best work outside public scrutiny, the CEO and staff have improved governance and delivery of outcomes to our membership and sponsors. We expect this work to be rewarded by greater successes in the near future.

Our non successes –failures- were mostly in the results of our High Performance programme. This is not a reflection on the staff athletes or coaches but on the funding available to Table Tennis Australia. While it has been difficult to make the dollars stretch, I am confident in Table Tennis Australia's ability to succeed in this arena in the long term.

I am grateful for such a strong, ongoing commitment from our Directors. Barbara Talbot has brought her expertise as Director of Finance to the board as well as her vast knowledge of AWD. Phil Males the Vice President with his involvement with Oceania and his vast experience in table tennis administration. We are indeed fortunate to have Graeme Ireland as one of our directors who brings his International and Officiating experience with ITTF. Leonie Whiteford has many years experience in domestic and international competition and in veterans table tennis. Phil Davis has experience in many areas of administration and the running of international competitions and High Performance. William Henzell brings the players perspective to the board discussion and with his many years of experience.

Finally, I acknowledge the hard work and dedication of our office staff. Even though we are a small organisation the amount of work that comes from the office is staggering considering the number of people involved. I thank Sue Stevenson who continues as the glue binding Table Tennis Australia and also Adele Butler our Administration Officer. Over the past year I have worked closely with CEO Peter Marriott and am impressed with his ability in administration and communication.

CEO Annual Report

PETER MARRIOTT

2010 has been a busy year for the office; Adele Butler joined the team as Administration Officer in May and has done a tremendous job in learning the systems and keeping the accounting records up to date. Sue Stevenson continues to excel as the National High Performance & Coaching Coordinator and has helped maintain a close relationship with our key Stakeholders. Brett Clarke spent a lot of the year travelling to events with both junior and senior teams. After holding the National Coach position for 18 months Brett will be missed by all the players after finishing his employment on the 31st of December.

Will Goodier and the Board have maintained a stable leadership of the organisation and have continued to drive the sports attempts to improve Governance. I would also like to acknowledge the many volunteers who donate their time to the various committees of Table Tennis Australia.

Achievements in 2010

After 12 months of discussion and planning with member state / territories, the Australian Sports Commission and our Lawyers, the new constitution and organisational structure was adopted at Special General Meeting in October. Table Tennis Australia has now changed its structure to a Company Limited by Guarantee with a new and modern constitution and positions the sport in line with the governance principles of the Australian Sports Commission. Whilst the process took 12 months to complete, everyone involved should be congratulated on their efforts as many other National Sporting Organisations are still working through the process. Table Tennis Australia is committed to providing the best governance for our sport and continues to work closely with the Australian Sports Commission in achieving this goal.

The Board of TTA has undergone a number of changes this year as it was left without a Finance Director for the first few months of the year with the resignation of long time Board member Peter Campbell-Innes. Barbara Talbot accepted the position of Finance Director in late May. Barbara has brought her finance skills and a wealth of knowledge and experience with AWD to the Board. David Beaumont stepped down at the Annual General Meeting and was replaced by Leonie Whiteford. Phil Males was elected Vice President of the Board during the year (position previously held by David Beaumont).

The National Insurance Scheme finished its first year of operation and has been renewed for the 2011. Premiums have been maintained and the level of cover has been increased. State & Territory Associations are now able to provide player accident cover for members and clubs are provided with Public Liability, Professional Indemnity and Associations Liability to protect their committee members. Travel Insurance has also been provided to all Australian and State representative players competing in national level domestic and international events.

The Paralympic Preparation Program continues to go from strength to strength under the guidance of Roger Massie (Head Coach), Alois Rosario (Assistant Coach) and Barbara Talbot (Manager). The squad is made up of 20 athletes from Classes 4 to 11 who attend quarterly camps and selected AWD Events. With the assistance of the Australian Paralympic Committee the squad receives tailored

support from dedicated Sport Medicine and Sports Science specialists and funding to attend the quarterly camps. Sarah Lazzaro and Rebecca McDonnell qualified for the Para World Championships in Korea in October. Whilst 2010 had few international events, 2011 will see a huge international schedule as our Tier 1 athletes embark on the qualification process for the London Paralympics in 2012.

The XIX Commonwealth Games were held in Delhi and the Australian contingent of 5 male players, 6 female players, 2 coaches (Brett Clarke and Alois Rosario) and 1 section manager (Sue Stevenson) did the country proud in their efforts both on and off the table. Catherine Morrow thrilled Australia with a Silver Medal in the Women's Singles – Para Event.

Whilst the results of all the tournaments conducted during the year are contained later in this annual report, I would like to acknowledge the efforts of the State/Territory committees and volunteers who hosted the major events during the year.

Congratulations to all of the players who competed in these events and a big thank you to all of the Coaches and Managers for helping make these events possible.

Stakeholders:

A lot of the above events would not be possible without the continued support of our major funding partners and stakeholders. Our Principle Funding Partner the Australian Sports Commission continues to support our sport not just in the provision of finances but the support and resources given through their staff at the Sports Commission is indispensible. A special thank you to our Sports Consultant Kim Williams, who has continued to assist TTA throughout 2010.

The Australian Paralympic Committee has increased their support of AWD Table Tennis in 2010, with funding and resources have ensured that every possible opportunity will be given to our PPP athletes in their efforts to qualify for the 2012 Paralympics. The APC have also assisted TTA in developing a Classification pathway and course for our sport and have helped us develop a Sports Science and Sports Medicine program for our PPP athletes which would rival many able and disabled programs around the country.

It would be remiss of me not to mention the tireless efforts of the Australian Commonwealth Games Association. The ACGA continues to provide financial resources to the sport of Table Tennis to allow our athletes to prepare for the Commonwealth Games. The ACGA has also provided much needed funds to assist in sending the Australian Junior Team to the World Championships. In addition to these financial resources they have worked hard to ensure that the Athletes were kept up to date in the chaotic build up to Delhi and made sure that the games would be a memorable occasion for the athletes and team staff.

Looking Ahead:

2011 will be a big year for our Paralympic hopefuls as they will need to attend at least 6 international events to achieve sufficient ranking points to qualify for the London Paralympics in 2012. We wish them all the best for their endeavours to qualify for London.

2011 will also see the start of some new domestic events which will see the High Performance program move from a daily training environment to a camps/events based model.

However the greatest challenge ahead of us in 2011 will be the introduction of additional funding from the Australian Sports Commission to increase participation in the AWD and CALD (Culturally and Linguistically Diverse) segments of the population. TTA will be working with identified States and Clubs over the next 12 months to develop programs which will increase participation in these 2 sectors and ultimately result in increased membership of Table Tennis Australia. Work has commenced with a review of membership categories and database model to ensure that we have resources which will allow us to capture the various participants of our game. While development has always been the domain of the State/Territories and Clubs; TTA will also now play a role is assisting them thanks to this investment from the ASC.

In closing I would like to thank all of the State and Territory Associations for their continued support of TTA and a big thank you to the Staff of TTA for their tireless efforts.

Message from the Australian Sports Commission

It is an honour to serve as the new Chair of the Australian Sports Commission (ASC) Board at this challenging and exciting period for our national sporting system.

The ASC and national sporting organisations (NSOs) have long spoken of a shared ambition to strengthen relationships between all system partners involved in Australian sport.

Aligned with this ambition, the Australian Government is now encouraging a whole-of-sport reform agenda, aimed at establishing a more collaborative, efficient and integrated sports system.

Through new direction for sport 'Australian Sport: the Pathway to Success', the ASC will work closely with sport to achieve its main objectives; boost sports participation and strengthen sporting pathways while striving for international success.

The reform agenda seeks for the ASC to assist to provide stability and support for all sporting organisations in their pursuit of a shared, common purpose; creating a better sporting pathway for all Australians, from the grassroots up.

The ASC will implement the new direction, and this includes collaboration with all NSOs to allocate a record amount of new sports funding – committing an extra \$195 million over the next four years.

This funding is in addition to the current ongoing baseline funding for NSOs. Also, the ASC will assist sporting organisations with access to coaching and officiating programs, governance support, planning and education opportunities and assistance with becoming more inclusive – particularly in the areas of Indigenous sport, sport for people with a disability, sport for people from culturally and linguistically diverse backgrounds and women's sport development programs.

This is the first time key sport partners, such as state and territory institutes and academies of sport and state and territory departments of sport and recreation, have collaborated on a Commonwealth funding decision in the interests of Australia's sporting future.

This is an exciting time for all of us involved in Australian sport. With significant new funding from the Australian Government, sports will be better positioned than ever before to lead the drive for higher participation levels and strong success on the sporting field by promoting the unique nature of their sport, creating a legacy and a lasting impression for communities across the country.

The ASC will continue to work with all NSOs, the state and territory institutes and academies of sport and state and territory departments of sport and recreation, reinvigorating access to, and participation in, sport across the community and driving Australia's continued sporting success.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2010

1 Statement of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act SA. The committee has determined that the association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

Income Tax

The income tax expense (revenue) for the year comprises current income tax expense (income) and deferred tax expense (income).

Current income tax expense charged to the profit or loss is the tax payable on taxable income calculated using applicable income tax rates enacted, or substantially enacted, as at the end of the reporting period. Current tax liabilities (assets) are therefore measured at the amounts expected to be paid (recovered from) the relevant taxation authority.

Deferred income tax expense reflects movements in deferred tax assets and deferred tax liability balances during the year as well as unused tax losses.

Current and deferred income tax expense (income) is charged or credited outside profit or loss when the tax relates to items that are recognised outside profit or loss.

Deferred tax assets and liabilities are ascertained based on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the financial statements. Deferred tax assets also result where amounts have been fully expensed but future tax deductions are available. No deferred income tax will be recognised from the initial recognition of an asset or liability, excluding a business combination, where there is no effect on accounting or taxable profit or loss.

Deferred tax assets and liabilities are calculated at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates enacted or substantively enacted at the end of the reporting period. Their measurement also reflects the manner in which management expects to recover or settle the carrying amount of the related asset or liability.

Deferred tax assets relating to temporary differences and unused tax losses are recognised only to the extent that it is probable that future taxable profit will be available against which the benefits of the deferred tax asset can be utilised.

Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

Foreign Currency Transactions and Balances

Transaction and balances

Foreign currency transactions are translated into functional currency using the exchange rates prevailing at the date of the transaction. Foreign currency monetary items are translated at the year-end exchange rate. Non-monetary items measured at historical cost continue to be carried at the exchange rate at the date of the transaction. Non-monetary items measured at fair value are reported at the exchange rate at the date when fair values were determined.

Exchange differences arising on the translation of monetary items are recognised in the statement of comprehensive income, except where deferred in equity as a qualifying cash flow or net investment hedge.

Exchange differences arising on the translation of non-monetary items are recognised directly in equity to the extent that the gain or loss is directly recognised in equity, otherwise the exchange difference is recognised in the statement of comprehensive income.

Employee Benefits

Provision is made for the company's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits have been measured at the amounts expected to be paid when the liability is settled, plus related on-costs.

Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities on the balance sheet.

Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. Any consideration deferred is treated as the provision of finance and is discounted at a rate of interest that is generally accepted in the market for similar arrangements. The difference between the amount initially recognised and the amount ultimately received is interest revenue.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

Revenue recognition relating to the provision of services is determined with reference to the stage of completion of the transaction at the end of the reporting period and where outcome of the contract can be estimated reliably. Stage of completion is determined with reference to the services performed to date as a percentage of total anticipated services to be performed. Where the outcome cannot be estimated reliably, revenue is recognised only to the extent that related expenditure is recoverable.

All revenue is stated net of the amount of goods and services tax (GST).

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.

The Southern Junior Development Squad and the Academy both ran throughout the year and both were successful in raising the skill levels and participation of our junior players as was evidenced by being able to send a team of 18 players to the National Junior Championships in October. Huge credit must go to the Directors responsible for these coaching initiatives and for the sustained success of them: it took much dedicated and skilled work for this to happen. So thank you to David Wilson (Academy) and Andrew Goodsell (SJDS) in particular, and to the coaches who assisted for this major step forward.

As mentioned we were able to send a larger team to the National Juniors, and what is particularly encouraging is that we were for the first time in a long time able to field a girl's team instead of just individual girls in a President's team. Moreover, we sent two! The players performed creditably, and Madeleine Goodsell is to be congratulated in becoming the first junior to be ranked in the top 10 nationally this millennium.

Thanks go to Susan Loveless for undertaking the daunting task of team manager for such a large team, and to the non playing captains – David Wilson, Andrew Goodsell, Brendan Black, Elaine Wright, Chris Hooper and Luke Vaiciulevicius.

Tasmanian Table Tennis Association Inc. - Continued

An enthusiastic team went to the National Veterans' Championships under the management of Maureen Sherman; an enjoyable time was had by all. Young Dave Sherman obtained a National ranking in the Over 80 age group – well done Dave!

TTTA has taken up its option of holding the 2011 Australian Open. The venue will be Kingborough Sports Centre, and Marshall Muller has been appointed Chairman of the Organising Committee. Arrangements are well underway, including the procurement of two grants to help with the funding of the event: one from Sport and Recreation, and one from Events Tasmania.

Probably the only downside to the year was the failure to spend the \$7500 grant we received from Sport and Recreation for development programmes for juniors: this was in part due to the difference in interpretation of the word 'elite' between us and them, which resulted in us being unable to use the money to help fund the SJDS. The grant has now been renegotiated for this year for spending by the clubs on introductory programmes below the level of the SJDS. It will have to be spent this year or it will be forfeited. TTTA and all Branches also received a dividend during the year from the profits of the 2009 National Juniors Championships at Kingborough: this was most welcome, and we thank STTTA and the Tournament committee for it.

Administratively, we managed to keep everything running smoothly, with each Director fulfilling their portfolios. Doug MacLean has again been a very able and conscientious registrar, recorder and manager of the web page. This year will see the end of David Higgins' and David Hudson's tenures as Directors. These two gentlemen have worked effectively in their roles for several years, and on everyone's behalf I thank them for their considerable input to the running of the TTTA. We wish them well.

I would like to close by saying that we do need to be constantly looking for people to step forward to help with the many aspects of running a sport like table tennis. Without a continuing input of new recruits, the burden falls on too few people, which can result in organisational shortcomings. That these shortcomings have not really eventuated is due to the devotion to duty of the few.

I wish TTTA, its players and administrators a successful and enjoyable year in 2011.

Western Australian Table Tennis Association

Western Australian Report to TTA - IRWIN PARKER

Year 2010 was a difficult year for the WATTA board due to forced resignations in July of the President, Match Director and the death of Life Member and Association stalwart Doreen Bridson. Only three Directors were elected at the AGM and Sue Campbell stayed on until David Brown was appointed as President in late November. When Chris Hibbert, Margaret Collins and Ben Banerjee accepted invitations to join the board it seemed that we would have a full compliment of Board members for the year until the two resignations. In relation to the Executive Director position, problems were experienced in relation to recruitment and retention although the association was able to get by; some stability in this area is needed.

Chris Hibbert with the assistance of Sue Campbell and James Lu did an excellent job in running the Grand Prix, the West Coast Open and State Championships. David Brown ran all but one of the Junior Graded Tournaments and the Kingsway Cup until he became ill. Five metropolitan and one country club also conducted open tournaments. There are too many club officials who were involved in running these tournaments to mention in this report but special thanks goes to all these members.

Match Director and Official Scorer Kip Chang unfortunately were forced to resign due to other commitments. Fortunately Chris Marsh stepped in as Official scorer and quickly got up to speed. The situation was helped by having effective Match Committee members in Lindsay Mee and Rick Lewandowski. Unfortunately the new rating system had to put on hold.

Dennis Chen took on the dual roles of Coaching Director and State Coach achieving heartening results with our junior players. Margaret Collins took on the job of fundraising with great zest raising over \$1000 for the junior state teams. Ben Banerjee looked after the web page constantly improving it. In this modern age this has become the window of the Association. Based on the number of enquiries received it is apparent that the site has been the subject of an ever increasing number of hits.

Also outside of the Board members there were numerous contributors; notably Greg Letts as our editor of "11UP", Russell Lamborn as Chairman of the complaints Tribunal, Maureen Hooper, our gardener, Cedric Wilson and Paul Andriessen. Peter Mascall continues as the Canteen proprietor and collects Association fees and assists with events.

Due to serious fretting and the impeding collapse of a lintel above the high front windows, the front wall of the centre was to a large extent rebuilt and the roller door bricked in. I would like to acknowledge the assistance of Mike Andrews in arranging a tradesman and Lindsay Mee for his painting of the new work. This work together with the great improvement in the garden has greatly improved the external appearance of the centre.

The Association's incurred a loss of \$7173 which was mainly due to the cost of work on the front of the centre. Otherwise the Association more or less broke even after allowing for a significant increase in the costs associated with sending away our State Junior teams. Centre profit was reduced to around \$18,000 being reduced by the cost of renovations and increased operating costs, in particular electricity.

Western Australian Table Tennis Association - Continued

Core funding from the Department of Sport and Recreation (DSR) was maintained at \$16,000. Although appreciated, it is worth noting that the real value of DSR support has diminished significantly since the early 1990's. The reason for the level of support lagging can be put down to our membership numbers remaining fairly stagnant over the past few years.

Development funding from Healthway remained at \$12,500. Future funding has been tied into calendar years and I am pleased to announce that funding of \$17,000 has been approved for the 15 months commencing 1 October 2010 and \$15,000 for the 2012 calendar year. Healthway income was supplemented by the ASC'S 'Active After School' program which complements the other development activities of the Healthway program.

Overall the Association is in a very sound financial position with current working capital (Current Assets less Current liabilities) in excess of \$32,000 and having \$22,000 in the Centre Fund which will be needed if we secure a new venue.

There is a strong prospect that the Association will have a new home in the near future. As a result of groundwork carried out over the last three years by Board members, there is a plan for the Association to be part of a new sport complex in Roberts road Carlisle. The Association is represented on a Town of Victoria Park committee which is developing a business and feasibility study for a complex which has an \$8.5m budget. A decision on this should be reached next year.

Western Australia took part in the National Tour by Table Tennis Australia. This tour, funded by the Australian Paralympic Committee, not only covered disabled sport but numerous other areas. It is a pity that only 10 attended as this sort of forum can lead to more members' involvement in the general advancement of the sport.

The Association again supported participation in all the national open championships; Seniors, AWD, Junior & Veterans. We also entered a team in the youth championships but regrettably this event was cancelled. WA players won medals in the AWD and Veterans Championships.

I make special reference to coaches David Brown, Nanako Nomura, Phil Ranger, Dennis Chen, Frank Kenny and Peter Jokic. David Brown, who runs our disability program in addition to his schools coaching, running of junior tournaments, providing technical support for our office computers and running two clubs, had his activities curtailed for health reasons but is now back on board. Phil Ranger (Snr) continues as the Saturday morning junior coach as well as organising the highly successful Morley Club. Nanako & 'Jock' have been involved in school coaching south of the river. Frank Kenny has a number of regular pupils for coaching and has introduced a number of new members to the Association.

ACT Table Tennis Association

President's Report -GLENYS JOLIFFE

A VERY BIG "THANK YOU" to all our Members, Volunteers, Board Members, Sport & Recreation Services and Paul Pinkewich, for their continued support shown to our Association during 2010 – it has been very much appreciated.

Also thanks to one of our TTACT members, Baldev Bedi, for his sponsorship of a day's hire of mPowerDome for the Australian Athletes with a Disability Table Tennis Championships. Many thanks to mPowerDome (and staff) for their generosity and support over this period.

Our membership numbers have increased to an all-time high of 335. We continue to have two big problems, one with overcrowding and the other with the age of the building and the continued expense needed for its upkeep.

We are hopeful that this year our Association will be able to follow-up with plans (in conjunction with Tennis ACT) for an additional small venue, at the Lyneham Sporting Precinct. Hopefully the architects will be able to start drawing up plans soon, with a tentative completion date of mid-late 2011.

Sport and Recreation Services (formerly Sport & Recreation ACT):

- Many thanks to Sport and Recreation Services, for their continued support with the Triennial Grant Program, and their support – re: getting us involved in the proposed Tennis Regional Sporting Complex at the Lyneham Regional Sporting Precinct.
- This year as the first year of the new Triennial Grant Program, there has been an increase in the funds allocated over the three-year period to enable Table Tennis ACT to further progress their professional approach to running the Association.

Lyneham Regional Sporting Precinct:

The latest news is that Tennis ACT is awaiting news from the Government as to how they perceive the latest report submitted by Tennis ACT. We will report to our Association Members as further information comes to hand.

Visit by Table Tennis Australia President and High Performance Manager:

- Will Goodier and Sue Stevenson visited Canberra on the last weekend in March, as the first step in the State by State presentation of The National Tour. They presented a very interesting and complex program, which showed the direction the national body was taking to professionalise the organisation and that of its member states and territories.
- We had a very good response (approx. 20 people enlisting for the course), who covered a diverse range of interests within Table Tennis ACT and it was very well received by everyone on the day and stimulated follow-up discussions.

Australian Transplant Association Table Tennis Championships:

- Our Association was asked to assist in the exhibition function held on Sunday 19 September, at the beginning of Floriade, as publicity for the running of the Australian Transplant Championships, which were originally set to be held at the Australian Institute of Sport, but due to circumstances beyond their control, ended up being held at our Table Tennis Centre, at Kingston.

Table Tennis Queensland

President's Report - TREVOR BARRETT

This annual report represents a summary of various activities involving Table Tennis Queensland, its individual members and member associations during 2010. The detailed reports in the following pages outline the numerous aspects of our organisation including membership growth, financial status, governance and successes in table tennis at a state, national and international level. I am pleased to commend this report to the clubs and associations and recommend that it be made widely available to their individual members. Often our perception of our activities as a sporting body is influenced by what occurs in our own organisation. Hopefully the detailed reports in the subsequent pages will enable members to see that Table Tennis Queensland is a financially healthy and active organisation which aims to meet the needs of its members, and which has undertaken a broad range of activities during 2010 and achieved success in a variety of areas. Within this President's report, I do not wish to duplicate the detail of the specialised reports in the following pages, but I would like to highlight some specific aspects of our activities in 2010, and

offer some broad discussion.

At the outset, I would like to formally acknowledge the contributions of our CEO (Derek Scott) and Administrator (Karen Carruthers) for their contributions to our organisation during 2010. As I have said previously, the role of the Board is to determine policy, but unless the implementation of that policy is successfully driven, we will make little progress. Both Derek and Karen have contributed significantly to Table Tennis Queensland during 2010.

Within the Board itself, the beginning of the year saw Danny Lloyd (Brisbane) assume the role of Vice President, after the retirement of Jim Miller (Townsville) at the 2010 AGM. Later, Rosie Dittman (Mackay) resigned from the Board for personal reasons, and we welcomed Dr Katrina Forster (Townsville). We thank Jim and Rosie for their contributions during their period of Board membership. Your voluntary efforts in promoting and administering table tennis in Queensland have been very much appreciated.

The remainder of 2010 saw stability in the composition of the Board, although it would be pleasing to see the remaining Southern Board member position filled at the 2011 AGM, as it has been vacant for some time now. I have little doubt that within the southern associations there are many members whose experience and expertise would be a valuable addition to the Board of Table Tennis Queensland. I ask members of those southern associations to please consider nominating for this position.

The up-coming AGM also sees the completion, as part of our succession planning, of the two year terms of several Board members, including Rhonda Miller (Townsville), Susan Jones (Rockhampton) and myself (Bundaberg). On behalf of the membership of Table Tennis Queensland I would like to thank those retiring Board members for their contributions over the past two years and look forward to your continued association with table tennis in Queensland.

In terms of membership, 2010 saw a gradual improvement in our overall numbers of registered players. This has particularly been influenced by the dramatic rise in membership of the Far North Coast Association, and they are to be congratulated on their success in this area. Within other associations we have seen both increases and decreases in membership, no doubt for a variety of reasons. To those associations whose membership has waned, or remained at its previous level, can

I urge you to again review your approaches to securing new memberships, and renew your efforts in 2011. I have no doubt that those associations that are experiencing greater success in this area would be happy to share their ideas with other associations. I cannot stress enough that increased membership, particularly in the areas of Junior and Youth players is crucial to the continued development of our sport.

Throughout 2010 we staged a number of successful major tournaments in different locations around the state, and due credit must be given to the organising committees and volunteers from the various associations that volunteered to host out tournaments. Undoubtedly the largest undertaking in 2010 was the staging of the Australian Junior Championships on the Gold Coast. I had the opportunity of attending this event for the entire week, and you could not help but be impressed by the scale and organisation of this championship. Our players did themselves proud, and showed that we are very competitive with the top players from interstate. Feedback from other states about the event was very positive, and I would like to thank the organising committee, officials, volunteers, players, their families and anyone else involved with this event for enabling us to stage an Australian Juniors Championship that has been recognised as one of the best ever held. Full details from the Australian Juniors are included later in this Annual Report.

As mentioned, our officials and volunteers always contribute in a significant way to our successful events, and many of these people were recognised at the 2010 AGM, as listed later in this report. Two of our people however have recently achieved recognition "beyond the norm" and I would like to acknowledge their achievements. Lukas Kozak (Gold Coast) was a finalist in the Volunteer of the Year component of the Queensland Sports Awards, and at the same event Mick McShane was presented with a Service to Sport Award in recognition of his long and distinguished contribution as an Umpire/Referee. Congratulations to both men on your success.

In the area of player achievements, 2010 has also been a rewarding year, with 8 players being selected in National Squads. We maintained our overall number of medal placings at National Championships, and three of our teams were successful in becoming National Champions in the Teams events. Five of our members achieved individual National Championships, and for what I believe is the first time ever, a Queensland based male player, Bill Bates (Gold Coast) became a World Champion, winning the Over 80s title at the 2010 World Veterans in Mongolia. Congratulations to all of our athletes for your successes during 2010. Details of all results are included later in this Annual Report.

Financially, as you will read in the Treasurer's Report, Table Tennis Queensland is in a very sound position. This was greatly assisted by the financial success of the Australian Juniors event, and the continuing support we receive from Sport and Recreation Queensland. On behalf of all members of TTQ I would like to express sincere thanks to our CEO (Derek Scott), Administrator (Karen Carruthers) and Treasurer (Joe Clifton) for your efforts in the management of our financial affairs during 2010.

Overall, what emerges from this Annual Report is that there are many facets of our organisation, at both a state and association level, and that being successful overall requires us to continue working away in a multitude of areas to bring about gradual progress. There is an old adage that "whether you think that you can, or think that you can't, you are probably right". One good example of "thinking that you can" was undoubtedly the major extension to their premises that was undertaken by the committee and members of the Gold Coast association in 2010. While obviously an undertaking that was not without risk, the outcome is a significant gain to table tennis facilities on the Gold Coast, and to Queensland in general. Can I encourage all associations to critically review what worked well and what could have been done better in your club during 2010, and be prepared to take on new initiatives and set out a plan for progress where it is needed in the coming years. Not everything we do is always going to be successful. That is part of developing an organisation. But if we don't try, then we remain where we are or go backwards, and the outcome is guaranteed.

Finally, while this report has related to 2010, I'm actually writing it in early 2011. It is difficult not to reflect on the extreme flooding and cyclonic events that have impacted significantly on Queensland since December 2010. Hopefully none of our individual members or member associations has been too seriously affected by these events, but if they have, I trust that things are now well on the way to recovery, and that 2011 will see a return to some sense of normality. I encourage all associations to offer whatever support that you can to assist those of our members/associations affected by these events are obviously with these people.

To conclude, on behalf of the Board I would like to wish all members of Table Tennis Queensland a successful and productive year in table tennis in 2011.

Table Tennis Victoria Report to TTA – CHRIS HORWOOD

Victoria has enjoyed another successful year on and off the court. While Victoria was not as dominant as had been the case in years past, there were still significant achievements at National and International level. Victorian players provided significant numbers for Australian teams at all levels of competition. While the National Training Centre program concluded at the end of 2010, the solid foundation that had been laid will provide the impetus for further improvement.

TTV continues to develop partnerships that build pathways for elite athletes from regional areas into higher level programs. The successful Regional Sports Academy programs that have been implemented an the south west of the State and in Gippsland continue to provide players from these areas with elite level coaching without the need to travel to Melbourne regularly for coaching and training. The selection of players from both of these Academies for Victorian teams at the recent Australian Junior Championships in Queensland demonstrates the effectiveness of providing opportunities for these players closer to home. As the skills of their local coaches develops, so to will the skills and enthusiasm of the players. There are plans for at least some of the coaches from these academies to upgrade their accreditation levels in the near future.

Maribyrnong Secondary College, in the inner western area of Melbourne, has been established as the only State Sports School in Victoria. Five sports already have full-time programs in operation at the college; while a further 11 sports have associate sport status. TTV is pleased to note that the first athletes accepted as table tennis players into the Maribyrnong Sports Academy will commence in the first term of the 2011 school year. We are continuing to work with the school to increase the number of players in the Sports Academy program and to ensure that the planned table tennis training facility is built in the next phase of construction of the new Sports facility.

The 2010 Australian Veterans Championships was the major event in Melbourne on a participation basis held during the year. More than 360 players competed over the week in October in a very successful event. The TTV Veterans Committee and their tournament organisers are to be congratulated on the staging of such a successful event. The venue handled the large number of players with ease and provided the necessary infrastructure for a first class tournament.

TTV also staged one of the major competitions during the year, the Qualifying tournament for the Commonwealth Games in India. First class table tennis was the order of the day as our elite players strove to make the Australian team for the Games. Of those that qualified, 2 of the men and three of the women were Victorians, including first time Games representative Robert Frank.

While the planned move into digital radio planning was disrupted when the radio station partnered in a new talk radio outlet, TTV continues to explore the possibility of using this new radio format to increase the coverage of the sport. As the price of digital radios reduces, there will be grater opportunities for table tennis to make use of this medium.

The Commonwealth Games in India provided a significant boost in interest in the sport. Local newspapers sought out players representing Australia from their communities and the coverage in those papers was significant. While we were approached for some television coverage, none of these came to fruition.

TTV continues to take every opportunity to gain media exposure for the sport and posts results in the daily press wherever possible. The use of YouTube clips from our Premier League matches moves us into the area of new media which we continue to explore.

Table Tennis Victoria will continue to strive to provide the best facilities and opportunities for all players to develop their skills to enable them to participate in the sport to the best of their ability.

President's Report – DENNIS O'BRIEN

On the occasion of my second AGM as President and reflecting on 2010, it could be argued that there have been many steps forward with some steps backwards.

Again, it has been a busy year; one that has concentrated on trying to grow the membership of the Association both in players and Affiliated Clubs. In both areas we have had some success with the number of Affiliated Members expanding, particularly in regional NSW, and the number of registered players within the various levels.

I am pleased to welcome the new Affiliates from Lake Macquarie East Table Tennis Club, Nambucca Heads Table Tennis Club, Seals Maroubra Beach Table Tennis Club, Far South Coast Table Tennis Club, Sydney Table Tennis Club and Northern Beaches Table Tennis Club.

Last year we took the step of introducing a new membership level, called "Social". When implementing this we were aware that it would impact on numbers in higher levels, but the prime aim was to gain growth in overall numbers.

The table below indicates the changes within the Levels between 2009 and 2010. The number of "pensioners" reduced, as we expected, because many only play within their Club. The drop in "Competition" level cannot be explained, as it is doubtful that people who previously played in tournament suddenly decided to reduce to "Social" members.

There was a lot of work undertaken by many to make the national championship a success, particularly the senior organising group lead by Phil Males, Ian Finlay, Ted Davis, ably assisted by Jan Davis, Stephen Gillespie, Graham Boyton and several others.

The Committee of the Central Coast Table Tennis Association should also be commended for their efforts in making these Championships a success.

However it is the players who deserve most of the credit, New South Wales was well represented and we should be very pleased with their results and efforts.

2010

At this AGM we will see some additional new members joining the Directors and Executive. First I must thank David Beaumont for his long and continuous service to Table Tennis in this State and Nationally. Others are in a better position to tell David's story, but I must thank him for his loyal and supportive work while I have been President. However, like many of us, David believes it is time to allow new blood to be involved in our Association.

Phil Males, who stood down as Financial Director at the last AGM, is now standing down from the Directorship. Phil is another person who has been heavily involved in our State for many years. Of course Phil will remain closely associated with table tennis, as he is currently the TTA Vice President, and we believe he will continue in that role for another year. Also, Michelle Beaumont has decided not to stand at this AGM because of other commitments. I thank her for her efforts and look forward to seeing her participate again in the future.

I thank all the current Directors who have re-nominated and look forward to working with them in the coming year.

I would like to welcome as Vice President Elect, Guy Fainbloom. I see this as an important move to the "changing of the guard" over the next several years. I would also like to welcome the Directors Elect - Simon Leung, Tony Bo, Stephen Gillespie and Steve Bruton. I am sure they will make a good contribution to our progress in 2011 and beyond.

Last year I reported that we had been experimenting with new organisational structures, investigating new ideas for enhancing our administration and relations with our members and registered players. We are still looking at these initiatives and will be keen to make progress in this regard in the coming year.

One thing we did do in 2010 was seeing the introduction of the TTNSW Membership Card and the employment of Jason Lau to assist in the running of the office. It's been a steep knowledge ladder for Jason, and I believe that 2011 will see him take a more active role in the administration of TTNSW activities.

The TTNSW website and the on-line registrations for membership and tournaments was introduced in 2010 and have had some limited success. We plan to keep working on bringing the website up to date and be more interactive. We have changed some hosting arrangements and I also spent a lot of time in discussions with Sporting Pulse to have improvements made to the database. It was only in late 2010 that we have seen some of our requests implemented, so 2011 will allow us to make the site more relevant to members and affiliates.

I would encourage all members to regularly visit the site and make use of the on-line registrations.

The Loop, still remains an area in which I am not satisfied with. We will be looking to use Jason more to make this communication tool better used. Of course it would greatly assist us if registered players gave us up to date email addresses. The cost of stamps and sending mail is still rising.

Finally, I would again like to thank all Council and Executive members and particularly Ted, Jan and Jason, in the office, for their advice and goodwill over the past year. I believe that we will continue to develop this sport in the state and this can only be a benefit for our Affiliate members and players.

We have had SA Government support over the last few years and we are hoping that with that support continuing we will be able to keep the centre going.

Board Members

It is disappointing to note that not one application has been received for any of the vacant positions on the board. It is not possible for the state association to function without personnel who are prepared to give their time to work on behalf of the sport.

The Board has spent sometime looking at recruitment and possible contenders for vacant positions and a few people have been approached. While this has so far been unsuccessful we can but hope that the Board may be able to fill some positions after the AGM. Many of our current Board Members have been serving for several years and some are looking to have a break. Unfortunately with the number of vacant positions on the Board some are having to take on extra duties rather than taking the break they well deserve.
