

# Presidents Message

2007 has been a year of achievements for Table tennis Australia. Our new CEO has led the organisation toward pursuing excellence in many areas, particularly good governance. What has become apparent though is that our governance system is not structured towards producing the best outcomes for table tennis in Australia. It prevents Board Members and staff from operating with the responsibilities and accountabilities of true Directors. Unless this can be resolved the Board and staff will continue to have their time taken away from achieving success for TTA.



Despite this constraint TTA has achieved a lot this year and I have listed these below:

- Relationships with major stakeholders (particularly funding bodies) have been strengthened.
- Our Athletes With Disabilities program has received acclaim from many quarters.
- We had a junior win a World Junior Circuit event and other juniors defeated seniors ranked in the top 300
- Senior players defeated internationals ranked better than 30 in the world
- Our National Training Centres have provided venues and coaching to assist players
- The Athletes Commission has developed to become a regular source of ideas and feedback to the Board
- Our administrative functions have strengthened, particularly registration
- We have conducted an external review of the effectiveness of the Board, and begun to implement the recommendations

I would like to take this opportunity to thank all members of the Board, the staff of TTA and the Voting Members for their work across the last twelve months. The dedication of the staff, way beyond the hours they are recompensed for, is admirable.

# CEO's Report



A great percentage of time in 2007 was spent in laying the foundations for future success in table tennis: – for both Table Tennis Australia (TTA) as an organisation and, for the sport of table tennis in Australia. There were many achievements that have placed TTA in a good position to further improve the sport in 2008. These achievements are outlined below along with some of the challenges faced in the quest for future success.

#### **ACHIEVEMENTS IN 2007**

The Board of Management remained intact for all of 2007 with the incumbent members being re-elected at the Annual General Meeting. This stability allowed the group to continue its strategic direction

for the organisation and the sport.

In a quest for best practice governance, the Board commissioned a review of its practices via a formal, independent evaluation late in 2007. The Board Evaluation included a review of the board as a whole and a peer review of individual directors. The recommendations are to be released to the Voting Members early in 2008.

The Board members routinely involved themselves in governance education through reading materials, Board meeting evaluations, advice from the TTA solicitor and a governance education session at the AGM (which all states participated in).

The committees of TTA were reviewed with formal roles and responsibilities developed and one new committee formed (Events Committee). The advice provided by the committees was invaluable to the Board and staff of TTA, particularly in highlighting the state perspective.

The Board of Management developed into a strong, strategic, cohesive unit in 2007 with all individual directors contributing significantly with their time and knowledge and often at their own expense. It's ironic in sport that the people who hold the most responsibility are also the most criticised and least financially rewarded. I would personally like to thank the Board as a whole for their resolve in difficult circumstances, their dedication to their task and their support of the staff of TTA in 2007.

The level of staffing was increased in 2007 in order to provide increased levels of effective service to the members and to improve the development of the sport.





Sue Stevenson was re-employed in the dual role of High Performance Manager / National Director of Coaching in July. After a world wide search Marcus Gustafson (from Sweden) was employed as the National Head Coach in September. These two positions have proven to be especially important in the lead up to the 2008 Olympic Games. Matt Pound continued in his role as the Operations Manager.

I would sincerely like to thank the staff of TTA for their dedication to their jobs. The staff members have routinely worked more hours than they are paid for, have on occasion faced extreme adversity, have shown a willingness to work with and listen to others, continually strive for excellence and ultimately have proven themselves to be TTA greatest assets. The most re-


peated comment from TTA's' funding bodies is that TTA is doing a great job with very little resources which reflects directly on staff performance.

The TTA high performance program continued to improve with consolidation of the National Training Centres in South Australia, New South Wales, Queensland and Victoria. Marcus Gustafson had met most of the national squad players by the end of the year and had the chance to conduct a training camp before the World Junior Championships. Communication of the program also improved with the employment of Sue Stevenson, the High Performance Manager. Australian teams and individuals competed at the Australian Youth Olympic Festival, the World Individual Championships, the Commonwealth Championships, the World Junior Championships (boys only), the Oceania Junior Championships, the World Junior Circuit, the World University Games, Oceania Cadet Challenge, the World Cadet Challenge and the Pro Tour. Paul Langley (Section Manager) attended briefing meetings and a site visit to Beijing in preparation for the 2008 Olympic Games. Highlights of the year included Trent Carter being the first Australian to win a World Junior Circuit event (Venezuela) and make it through to the World Junior Circuit Finals.

Athletes with disabilities stepped up their international program in a bid for qualification for the 2008 Paralympic Games. Players participated in the Arafura Games, the Oceania Paralympic Championships, the Italian Masters, Asia and

Oceania Championships and the US Open. Congratulations to Sarah Lazarro, Rebecca Julian and Catherine Morrow who qualified for the 2008 Paralympic Games. An Australian team for players with an intellectual disability also participated at the 2007 INAS-FID World Cup in Japan.

Thanks must go to Paul Langley, Dennis Chen, Keith Mundy, Nicole Freeland and Marcus Gustafson for their efforts in preparing and coach-







ing / managing Australian teams overseas. Often trips do not go as planned and this group of people showed their versatility and resourcefulness in often difficult situations. Thanks also to Aussie Table Tennis for their continued sponsorship of the TTA high performance program.

Development initiatives of TTA in 2007 included a review of the Coach Accredita-

tion Framework, greater inclusiveness through Sports CONNECT and the Australia wide Ratings system.

The Coach Accreditation Framework was reviewed in conjunction with the Australian Sports Commission (ASC) to better suit the needs of table tennis. The framework now includes five levels of coach accreditation that directly relate to the standard of players' coaches and the competition level. The Level 1, Level 2 and Level 3 courses have been re-written and approved by the ASC. The National Director of Coaching delivered the new Level 1 course in all states and also delivered the new Level 2 and Level 3 courses in Brisbane in November.

A Level 1 Course Presenter training program was established with eight presenters throughout Australia being accredited by TTA to deliver the Level 1 course. The National Director of Coaching now provides mentoring, support and advice to the course presenters. Education sessions in the areas of training, mentoring and assessment have been developed for table tennis, in conjunction with the ASC. These sessions will be delivered throughout Australia in 2008 for any coaches that are required to supervise other coaches.

In 2007 TTA progressed to the Gold Level of Sports CONNECT (previously known as Project CONNECT) one of the first sports to do so. Sports CONNECT is an initiative from the Australian Sports Commission to provide funding for sports to become more inclusive of people with a disability in all areas of their operations. An audit into the effectiveness of the program was commissioned in the middle of 2007. The results found that the goals of Project CONNECT had not been fully achieved but acknowledged that significant progress had been made, and stressed that the table tennis community is still only at the start of the journey towards achieving full inclusion. Considering the resources available to table tennis, and comparing it to other sports of much greater size and capability TTA has been very successful in working towards achieving the goals of Project CONNECT.







The TTA Ratings system was implemented for the year with minor changes made after suggestions from the Athletes' Commission. Players of all levels have found the Ratings a useful way to track their results and to motivate them to move further upwards. I would like to acknowledge the time and effort that Phil Davis contributed to the TTA Ratings system.

TTA officials and volunteers continued their strong presence on the world stage. The following TTA members continued their representation at international level: Neil Harwood (ITTF Vice President Finance), Graeme Ireland (ITTF Technical Committee), Ron Kehoe (ITTF Equipment Committee), Dave Delpratt (ITFF Umpires and Referees Committee) and Phil Males (ITTF Rules Committee). Arthur Wilkes sat on the Oceania Table Tennis Federation (OTTF) board with a specific brief to develop activities for athletes with a disability. The efforts of these volunteers ensure that Australia continues to punch above its weight amongst the world decision makers.

The TTA Board and staff worked hard on enhancing working relationships with Voting Members and funding partners in 2007. TTA would be unable to provide a high performance program or develop the sport without the significant funding from the Australian Sports Commission, the Australian Commonwealth Games Association, the Australian Paralympic Committee and the Australian Olympic Committee.

The State and Territory Associations worked hard to deliver national programs and initiatives. The level of cooperation in the delivery of services increased in 2007 to the benefit of members. The range of resources available at State / Territory level varied enormously with many volunteers contributing significantly in their own areas. Diminishing volunteer numbers is a worrying trend across all sports in Australia. The Board and staff of TTA would like to recognise the significant contribution that state and club volunteers make to the operation and development of table tennis on a daily basis – the sport would be lost without them.

Some of the achievements of the States and Territories in 2007 included:

- The Police and Fire Games, Australian Junior Championships and the Australian Masters were run in SA
- Government funding in SA to contribute to the National Training Centre and a one off grant for establish junior competitions
- WA achieving success at the Australian Championships by winning gold in Veterans' doubles events and winning silver in the boys U13 team event.
- Over 100 competitors at the WA State Championships
- Air conditioning of the WA association centre
- Victoria conducted a very successful Super League
- Victoria dominated in most events at Australian Championships
- The majority of players representing Australia in 2007 came from Victoria
- Reunification of Associations in Tasmania



- Come and Try program for athletes with a disability in Tasmania
- Continuation of the highly successful Top Spin Challenge in Tasmania
- The involvement of NSW in preparations for the World Masters' Games in 2009
- 14 players from NSW being selected for the Australian squad
- Staging of the largest ever Australian Veterans' Championships on the Gold Coast
- Continuation of a state wide Development Forum for all clubs in Queensland
- An after school development program was set up in the ACT
- A qualified Level 1 course presenter in the ACT

To assist in planning for the future TTA held a National Conference in November to, amongst other things, discuss the roles and responsibilities of State bodies and the National body. This information has been used in the development of the 2008 – 2011 Strategic Plan. All participants found the National Conference to be useful for networking, information exchange and understanding of motivations. TTA plans to hold future National Conferences on a bi-annual basis.

TTA has been given the opportunity to present a whole of sport pathway for the next four years to the Australian Sports Commission, the Australian Institute of Sport and the Australian Paralympic Committee early in 2008. The development of this pathway will ensure that TTA is providing the best programs available within its current resources and provide clear directions for advancement in the sport for players, coaches and officials. The development of the National Pathway has assisted with the direction of the 2008 – 2011 Strategic Plan.

#### **CHALLENGES IN 2007**

Changes to some of TTA's strategies and activities presented challenges as well as achievements in 2007. The Board of Management were not afraid to change tack if, upon reflection, they felt that a particular new strategic direction was not quite right or the relevant procedures had not been put in place in a timely manner. Many TTA Regulations showed themselves as not being very user friendly due to over wording and undue processes. The Constitution is in urgent need of an overhaul after being added to on and off over many years.

The costs to run an international program have increased but TTA has not had an

increase in funding to cover those costs. At times, players were required to pay for their own expenses for international competition, particularly athletes with a disability. Coaches and managers had to work especially hard during international competitions as teams were often under resourced personnel wise.

The National Training Centres faced ups and downs with each State hav-





ing their own particular issues. Without the support of the States the NTCs would not operate and the States struggled either with coaching staff turnover or financial burdens. National squad members have made good use of the NTCs with most States combining training with their State squad members. TTA thanks Victoria, Queensland, New South Wales and South Australia for their continued support of their National squad



members and the National Training Centres.

TTA introduced a new national database but found that it was not meeting the needs of the sport. A new service provider was found at the end of 2007 and a new database, competition software and website will be in place early in 2008.

The Board of Management made a strategic decision to incur a loss in 2007 in order to expand staff support for the development of table tennis. This loss still allowed the Board to comply with it's earlier strategic decision regarding the amount of member reserves required as a risk management negator for any unexpected serious financial crises. Unfortunately, this loss was made greater by the incursion of excess legal fees due to a participant member threatening legal action against TTA.

#### **LOOKING FORWARD**

In 2008 the Board and staff of TTA will be looking to advance the achievements of 2007, particularly in the following areas:

- The completion of the 2008 2011 Strategic Plan utilising the results of the Board Evaluation process, the 2008 2013 whole of sport pathway, the results of the Sports CONNECT audit and general reviews of operational activities.
- Development of a National Under 13 mini cadet program
- Increased National competition opportunities
- Expanded international and domestic program for athletes with a disability
- The review of the umpires and referees accreditation framework and courses (as per the coach accreditation framework)
- The completion of the coaching courses for beginner entry level (Tops) and the curriculum for the Active After Schools' Communities Program delivered by the Australian Sports Commission.
- The effective use of the new national database, tournament software, website and the ratings system.



# Message from the Australian Sports Commission

Australia, for its small population and remoteness of location, continues to confound the world with its achievements on the international sporting stage. This position has been reached by the development of a comprehensive and effective national sport system that encourages sport and physical activity for all Australians and creates opportunities to enable those who are talented and motivated to reach their potential. 

#### PRINCIPAL ACTIVITIES

The principal activities of the Association during the financial year were to provide table tennis services to members of the Association and promote and administer the sport of table tennis.

#### SIGNIFICANT CHANGES

No significant change in the nature of these activities occurred during the year.

During the year the Association appointed a National Coach for an initial period of 12 months commencing September 2007.

#### **OPERATING RESULT**

The (deficiency) for the year amounted to (\$28,704) compared to a (deficiency) of (\$5,467) for the previous year.



#### OFFICERS' INSURANCE

During the year the Association paid a premium for a contract insuring all members of the committee. The insurance does not provide cover to the independent auditors of the Association

#### STATE OF AFFAIRS

Table Tennis Australia Inc. is in a sound financial position. During the financial year, the Association received significant financial support from various sources including:

- Australian Sports Commission
- Australian Olympic Committee
- Australian Commonwealth Games Association
- Australian Paralympic Committee

Storey Blackwood Chartered Accountants, audited the Associations expenditure of grant funds received from the Australian Sports Commission for the year ended 30 June 2007 and an acquittal for the total amount received was lodged with the Commission by the due date.

The Australian Sports Commission did not provide Direct Athlete Support (DAS) funding to table tennis athletes during the financial year ended 31/12/2007 as Australian Table Tennis players are not expected to be in medal contention at the 2008 Beijing Olympics.

The Association's Brisbane office is in a Queensland State Government building "Sports House" designated specifically for sporting associations. The rent/occupancy costs are provided by the Queensland state Government on favourable terms. Photocopying services are also available on site at favourable rates. Accordingly, TTA does not need to have a photocopier in its office other than a 3-in-1 unit which functions as a printer, facsimile, scanner and photocopier.

The Association employs 3 persons in the Brisbane office. At the time of preparing this Report, The Chief Executive Officer (CEO) is employed on a permanent part time basis working 32 hours per week and an Operations Manager on a part time basis working 20 hours per week and a High Performance/Director of Coaching on a part time basis working 32 hours per week.

TTA recognises the importance of supporting and maintaining the Oceania Table Tennis Region. Entry to several World events including the Olympic Games and some World Championship events are based on regional qualifications.

Following discussions with the Australian Sports Commission over several years and planning over two years, TTA has moved some emphasis away from funding overseas competition for athletes towards training programs for athletes within Australia. High Performance Squads have been selected and four National Training Centres (New South Wales, Queensland, South Australia and Victoria) have been established.



#### **GENERAL ACCOUNTING & FINANCE MATTERS**

The Association uses MYOB accounting software to prepare its accounting records. Direct expenditure in respect of grant income is collated using MYOB Job Centres.

The Association operates a Petty Cash imprest system.

The Association has an ANZ Business One Card Account. Three cards are on issue at the time of writing this report (Bronwyn Marshall, Marcus Gustafsson, Paul Langley). The cards are of assistance with travel expenses including internet bookings and ordering over the internet. The account provides reward points to the Association.

The Association has 2 bank accounts with the Commonwealth Bank. A "Cash Investment Account" for the purpose of all income and expense transactions and a "Business Online Saver" account. At the time of writing this Report the "Business Online Saver Account" attracts an interest rate of 7.15% pa and funds are available at call using the internet.

William HENZELL is the Athletes Commission representative on the Board. Peri Campbell-Innes and Claire Campbell-Innes are daughters of the Director of Finance of Table Tennis Australia Inc. Michells Beaumont is the daughter of a Board Member.

Payments of approximately \$3,000 were made to William Hensell to cover costs in attending various European Tournaments.

No other payments were made to these players except in accordance with Board Resolutions covering all players either on the basis of their selection in an Australian representative Team or on the basis of their World Ranking.

Phil Males, a Board member received approximately \$2,000 in respect of his work in organising the Australian Youth Olympic Games.
